NASGRO™ COMPUTER SOFTWARE PROGRAM VERSION \_\_\_\_\_ AND DOCUMENTATION  
SITE LICENSE AGREEMENT

Southwest Research Institute™ (“SwRI”) agrees to grant, and \_\_\_\_\_ (“the Customer”) agrees to accept, a non exclusive non-transferable license (the “License”) to use the program(s) delivered in executable code form, known as NASGRO™ COMPUTER SOFTWARE PROGRAM Version \_\_\_\_\_, and documentation delivered with this Agreement (the “Program(s)” and “Documentation”) (hereinafter Arising Intellectual Property, AIP) under the following terms and conditions. Such AIP is copyrighted.

- 1. **LICENSE.** Customer may install and use AIP at its site located at [ \_\_\_\_\_ *insert address of site here* \_\_\_\_\_ ] (Site). The Customer may not distribute such AIP to any third party or use at any other site without the express written consent of SwRI. AIP may not be changed or translated without the express written permission of SwRI. The Customer may copy for its own use and at its own expense an unlimited number of operator manuals, training materials, and other user-oriented materials but the Customer must reproduce and include SwRI’s copyright notice on any copy. All right, title and interest in and to AIP are and shall at all times remain the sole and exclusive property of SwRI. The Customer may not sublicense, assign or transfer AIP except as expressly provided in this Agreement. Any attempt otherwise to sublicense, assign or transfer any of the right, duties or obligations hereunder is void and shall terminate this license.
- 2. **TERM.** This Agreement and License are perpetual and apply to only Version \_\_\_\_\_ of NASGRO™. The Customer may terminate this Agreement and the License at any time by destroying AIP. The License will also terminate upon conditions set forth elsewhere in this Agreement or if the Customer fails to comply with any term or condition of this Agreement. The Customer agrees upon such termination to destroy AIP.
- 3. **LIMITED WARRANTY.** SwRI warrants the media containing such AIP to be free from defects in materials and workmanship under normal use by the original purchaser for a period of ninety (90) days from date of receipt.

**EXCEPT AS STATED ABOVE, THE PROGRAM(S) (AIP) ARE PROVIDED “AS IS” WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING, WITHOUT LIMITATION, IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.**

- 4. **LIMITATION OF REMEDIES.** The entire liability of SwRI and the Customer’s role and exclusive remedy, is limited to the replacement of any media not meeting SwRI’s limited warranty provided such defective media shall be returned to SwRI.

**IN NO EVENT WILL SwRI OR ANYONE ELSE WHO HAS BEEN INVOLVED IN THE CREATION, PRODUCTION OR DELIVERY OF THE PROGRAM(S) (AIP) BE LIABLE FOR ANY DAMAGES, INCLUDING WITHOUT LIMITATION LIABILITY ARISING OUT OF CONTRACT, NEGLIGENCE, STRICT LIABILITY IN TORT, WARRANTY OR PATENT OR COPYRIGHT INFRINGEMENT OR ANY INCIDENTAL AND CONSEQUENTIAL DAMAGES OR DAMAGES FOR LOST DATA OR PROFITS, ARISING OUT OF THE USE OR INABILITY TO USE THE PROGRAM(S), EVEN IF SwRI OR OTHERS HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES OR FOR ANY CLAIM BY ANY PARTY.**

- 5. **EXPORT.** Customer will not export the Program(s) and Documentation.
- 6. **GENERAL.** This Agreement merges all prior written and oral communications regarding AIP and sets forth the entire agreement of the parties. This Agreement shall be construed in accordance with the laws of the State of Texas, venue shall be in San Antonio, Bexar County, Texas. If any provision of this Agreement is ruled invalid under any law, it shall be deemed modified or omitted to the extent necessary, and the remainder of the Agreement shall continue in full force and effect.
