

U.S. GENERAL SERVICES ADMINISTRATION (GSA) OASIS+ December 17, 2024 - December 16, 2029

SUMMARY

OASIS+ is a collection of governmentwide, multiple-award, indefinite delivery, indefinite quantity (IDIQ) contracts to support federal agencies' procurement requirements for services-based solutions.

SCOPE AND DOMAIN SELECTION

Contract scope is organized by functional groupings (domains) of related services spanning multiple NAICs codes. SwRI's contract in the Research and Development (R&D) Domain includes:

- Any requirements in support of R&D activities;
- R&D activities aimed at achieving either specific or general objectives;
- Basic research, applied research and experimental development; or
- Services in the physical, engineering and life sciences; nanotechnology; biotechnology.

TASK ORDER (TO) CONTRACT TYPES

Task orders may include multi-year or option periods, performance-based procedures, classified and/or unclassified, and commercial and/or non-commercial items. OASIS+ allows for all contract types or combination of contract types at the TO level including:

- Fixed-Price (all types),
- Cost-Reimbursement (all types),
- Time-and-Materials, and
- Labor-Hour.

OASIS+ FAQs

- Funding Ceiling: OASIS+ has no ceiling.
- <u>Sole Source:</u> Allowed, as long as one of the exceptions to fair opportunity as listed in FAR subpart 16.505(b)(2)(i)(A) through (F) applies.
- Source Selection Procedures: Streamlined procedures found at FAR 16.505 govern the OASIS+ ordering process; FAR 15.3 source selection procedures are not applicable.

ORDERING PROCEDURE SUMMARY

Two ways to access OASIS+:

Direct Acquisition: Customer agency Ordering Contracting Officer (OCO) obtains Delegation of Procurement Authority and performs the acquisition;

or

Assisted Acquisition: GSA performs the acquisition on behalf of the customer agency and provides postaward support, as negotiated with the customer. An Inter-Agency Agreement is required.

WHO CAN USE THIS CONTRACT?

OASIS+ contracts may be used by all federal agencies.
